MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for Alphonso Haynesworth respectfully requests an extension of thirty (30) days in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today. The Court has granted counsel three previous extensions.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Shane Lamar Moore v. State of South Carolina with the Supreme Court on November 22, 2013. Counsel had an oral argument in the case of In the Matter of the Care and Treatment of Vince Neal Way in the Supreme Court on November 20, 2013. Counsel attended and participated on the CLE Appellate Practice Project Seminar at the South Carolina Bar Conference Center on October 24, 2013.


4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will

hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office consents to this request shown by signature below.




