NOTICE OF APPEAL

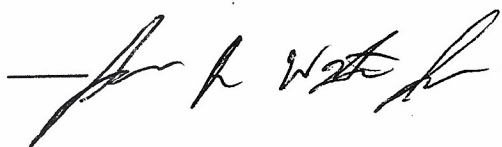

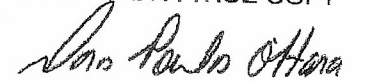

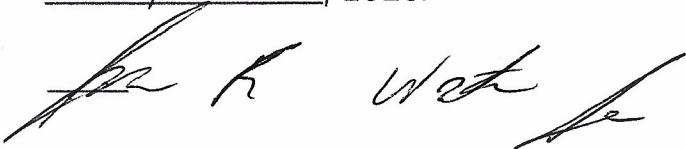
