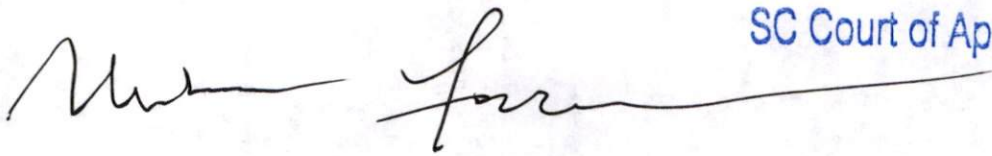

MOTION TO ALTER OR AMEND AND FOR NEW TRIAL - RULE 59(e), 59(a) SCRPC

*** SIX REVERSIBLE ERRORS - JUDGMENT AGAINST 5 MINOR CHILDREN ***

Plaintiffs move to vacate Order filed June 17, 2026 directed verdict "no evidence of negligence."

ERROR 1: EVIDENCE OF NEGLIGENCE IGNORED - TIRE BLOWOUT, SETTLEMENT OFFER, LEFT SCENE:

- Southeastern Freight driver blew tire on highway - failure to maintain.
- Same driver offered settlement declined - admission of fault / consciousness of guilt.
- Same driver left scene with 7 injured including 5 minors - negligence per se, GA law Columbia County GA, and consciousness of guilt.

ERROR 2: NO MAINTENANCE LOGS PULLED - FEDERAL LAW VIOLATION & SPOILIATION:

- Southeastern Freight Lines, Inc. is interstate motor carrier under FMCSA. Required by 49 CFR 396.3 to maintain and produce tire maintenance logs, inspection reports, repair records.
- No maintenance logs pulled or produced. No inspection logs. Failure to produce = presumption of negligence and spoliation inference. Court granted directed verdict without requiring Defendant to produce federally mandated maintenance records for tire that blew.
- Plaintiffs were not allowed discovery or subpoena of maintenance logs.

ERROR 3: NO OFFICERS OR WITNESSES SUBPOENAED - DENIED RIGHT TO PRESENT CASE:

- No officers who responded to highway blowout subpoenaed. No witnesses to blowout and leaving scene subpoenaed. Directed verdict for "no evidence" illegal when court prevents Plaintiffs from presenting evidence, especially case with 5 injured minors.

ERROR 4: TRUCKER NOT CROSS-EXAMINED ON TIRE, SETTLEMENT, LEAVING SCENE, LOGS:

- Southeastern Freight trucker never cross-examined on maintenance logs, tire condition, settlement offer, leaving scene. Cannot grant Rule 50 directed verdict where key witness not cross-examined.

ERROR 5: CHOICE OF LAW - GEORGIA LAW GOVERNS:

- Columbia County, GA accident - GA substantive negligence law applies under lex loci delicti. Under GA law, tire blowout + leaving scene + no logs = jury question, not directed verdict.

ERROR 6: MINOR CHILDREN - 3 minors Fulwiler/Caraballo including Amelina minor at time + 2 minors Isdell/Caraballo = 5 minors total - judgment against minors without full evidence violates public policy and due process.

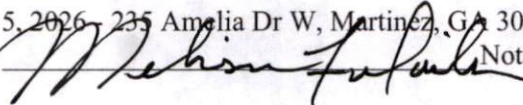

AFFIDAVIT OF MELISSA FULWILER - CASE 2024-CP-08-01717 - SUPPORT FOR RULE 59

I, Melissa Fulwiler, under oath:

1. Southeastern Freight Lines driver blew tire on highway Columbia County, GA causing injuries to 7 persons: myself, Manolin Caraballo, Amelina Caraballo (minor at time), Haley Isdell, Justin Caraballo, and 2 minor children of Isdell/Caraballo.
2. Same driver offered settlement which we declined.
3. Same driver left scene despite injuries to 5 minor children.
4. No maintenance logs, tire inspection logs, repair logs for blowout tire were pulled, requested, or produced by Southeastern Freight Lines, Inc.
5. No officers who responded to highway were subpoenaed and no witnesses subpoenaed at trial in Moncks Corner, Berkeley County.
6. Southeastern Freight Lines trucker driver was not cross-examined on tire maintenance, settlement offer, leaving scene, or logs.
7. Total: 3 minor children of Fulwiler/Caraballo including Amelina minor at time, and 2 minor children of Isdell/Caraballo = 5 minors.
