MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE INITIAL BRIEF OF APPELLANT
AND DESIGNATION OF MATTER

Counsel for William David Gunn respectfully requests a **fourth and final thirty (30) day extension from July 22, 2026, until August 21, 2026**, in which to serve and file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today.
2. Counsel for William David Gunn respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

3. Counsel filed the Anders Brief of Appellant and Record on Appeal in the case of The State v. Robert Tyrwick Hoffman with the Court of Appeals on July 9, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of David R. Dozier v. The State with the Supreme Court on July 9, 2026. Counsel filed the Petition for Rehearing in the case of The State v. Measha Jaquetta Shawnic Joyner with the Court of Appeals on July 2, 2026. Counsel filed the Initial Brief of Appellant in the case of The State v. Kasiem Rashawn Stephens with the Court of Appeals on June 26, 2026. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and Appendix in the case of Anthony Briggs v. The State with the Supreme Court on June 19, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Ralph Jake Goss, Jr. v. The State with the Supreme Court on June 10, 2026. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Jose R. Reyes v. The State with the Supreme Court on June 5, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Daryl Lamar Quarles v. The State with the Supreme Court on June 1, 2026. Counsel filed the Johnson Petition for Writ of Certiorari and Appendix in the case of Samuel L. McNeil v. The State with the Supreme Court on May 22, 2026. Counsel appeared for Oral Argument in the case of The State v. Measha J. S. Joyner before the Court of Appeals on May 14, 2026.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

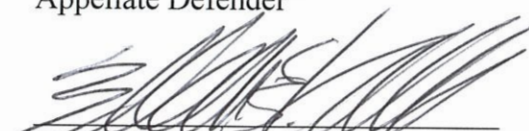

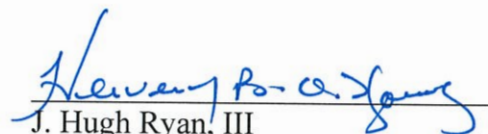
