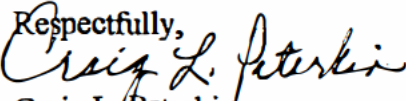
STATEMENT OF NO PREJUDICE

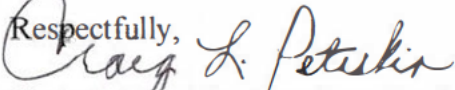

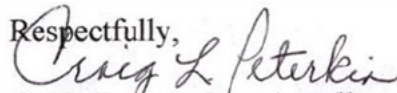

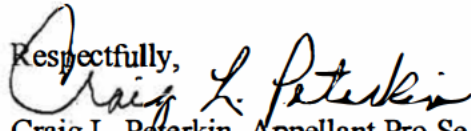
