Today on July 20, 2026 I Received A letter From my Public Defender Mr. Jerry White III From Lancaster County Public Defender office of Lancaster County. To day on July 20, 2026 that I had 20 Day's to Response Book with my owe writing arguable basis on my issues. I wanna think the court of appeal for taking time to hear my case out But on the date of March 2, 2026 I was looking to court For my First court Date on all ten of my case's that was pending towards me since 10/07/23. My Attorney Ms. Jerry White was Assigned my Case 34 Day prior of me going to court the Date of March 2, 2026 was the First time we met and to my knowledge we was facing two account's of Distribute when I met with my Attorney I told him about how when I was in Lancaster county I met with A Detective Lockhart and we made a agreement that IF I give him my person that I was getting the Drug's From that he would get me A Bond and Drop all charger's

I had Been in Lancaster county For 34 Day on Arr
to Bond. But while in the county Jail I was place
with A Public Defender By the name of Mr. Bill
Nowick. Once I was I was giving A Bond I spoke
with my Attorney Bill Nowick he A sured me
that he was the one that Got me A Bond on
that he never spoke with Any Detective ~~that~~ also
he explained to me when he was giving my case
He noticed that all my charges had Been Run
through magistrate court so that's why I was Deind
Bond After Being Release in November of 2023 I
spoke with mr. Bill Nowicky After I made
Bond he said he would Parther in my case But
Two year's had passed By and we lost contact
But Every month I would call Lancaster county
try to see if anybody had Be Resigned but For
two years it was nobody to my knowleaged asigned
to my case. But while I was out on Bond I was
Contact By A D.E.A Detective that told me that
the Information I give lead to two Arrested and
they Need me to get more Information But I explained to
the Detective

That I was from Rock Hill and since I had moved to Lancaster there was the only people I was dealing with. And that I had got clean and wasn't doing the drug anymore. And that was the year of 2025 when I made contact with that Detective a few months later on January 26, 2026 I was contacted by Mr. Jerry White and he told me he had been assigned my case and that I was put on the court dock for trial. I had explained to my attorney that I worked out a deal and I was told long as I keep my nose clean I wouldn't face them charges also that I wasn't in my right state of mind due to the passing of my mother who we just buried on January 23, 2026 so he explained that I should come in on the above date of March 2, 2026 and he would put in for a motion to continuance and we will be able to look in my case more so I agreed to come in on that date. But once we got there I was told that I was facing two accounts of distribution and that the court wanted to proceed that day. So I explained to my lawyer that me and the CI did some of the drugs that day and she gave me "oral sex" for the drugs with her.

So my Attorney want and spoke with the prosecutor that same Day of March 2, 2026 about the new's we had just spoke about. like 15 min later my lawyer Returned ~~to~~ Back in the Room with me and stated that my prosecutor said that she was not willing to use the Distribution charges any more that the state wanted to pick up the Trafficking. An they went to take me in front of the Judge the same Day I explained to my lawyer that I just lost my mother that I wasnt in my Right mind to face A Judge the Date of March 2, 2026 and that I did not wanna take a plea that we needed more time to go over the end and out's of my case. I also spoke with my lawyer about trail he told me that they would pre screen me that Day then take me to trail that ~~the~~ next Day I asked he with he Been'ing on my case only 34 Days and they saying they Don't wanna use the Charges that lead to the Search warrant had to be a issue my lawyer said that we had to go in front of the Judge that Day and he would see what the Judge will say

But the motion to continue I agreed and we
proceed to go in front of Judge Burch. But he
Denied my motion and state that we was going to
make A desion on my case that Day so me and my
Attorney want Back in the meet Room and he told
me ~~that~~ I had no opion from that ~~point~~ point
But to accpet what the State was offring or I would
have to go to trail the next Day on all Charges wich I
could face up to ^{35 year} ~~ten~~. But in the middle of the Decison
my lawyer explained to me that he could get me A
delayed of sentencing witch ~~could~~ ^{be} the only
way I could make it home that Day but I would
still have the Decison to pull back From It explained that
I had a meat heath appointment that same month on
March 19, 2024 that I wasent at my Right meath
stage. ~~but~~ I Just ask the Appeal court to hear my
Plea and cry I Really didn't wanna take the
Delayed of sentencing But with my Lawyer only having
my case 34 day and they was pushing for trail with an
