20, 2025 to the indictment number above and I Received A sentence of
Fifteen (15) YEARS which was suspended upon the service of eighteen
(18) months with 435 Days Credit to my sentence. THE Sentencing
Judge Jane H. Merrill Allowed ME to SERVE the Imposed sentence on
Home Detention, monitored by the Spartanburg County Sheriff's Office.
Following A Violation of Home Detention on April-11-2026 For Public
Disorderly Conduct I was Arrest in Lock up For I went to Court
on June 9-2026 BEFORE Magistrate Court and the Judge Dismiss
the charge of Public Disorderly Conduct My Counsel Filed A motion
to Reinstate Home Detention. THE STATE subsequently Filed A motion
to Convert My Sentence to AN ACTIVE Department of Correction Sentence.
THE Motion was Heard on June 15, 2026 by Honorable Judge Carmen Mullen
AFTER the Hearing, THE Judge Converted Ten (10) Years of my sentence.
