Counsel filed the Anders Brief of Appellant and Record on Appeal in the case of The State v. Jimmie McMillan with the Court of Appeals on June 15, 2026. Counsel filed the Reply to Return to Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Jharaun Washington with the Supreme Court on June 12, 2026. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Marc Anthony Palmer with the Supreme Court on June 12, 2026. Counsel will file the Anders Brief of Appellant in the case of The State v. Charlecia Lurry with the Court of Appeals today, June 5, 2026. Counsel filed the Initial Brief of Appellant in the case of The State v. Tyler J. Givens with the Court of Appeals on May 29, 2026.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that his caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

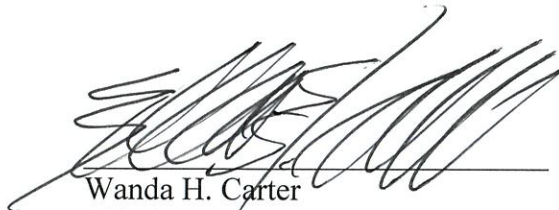

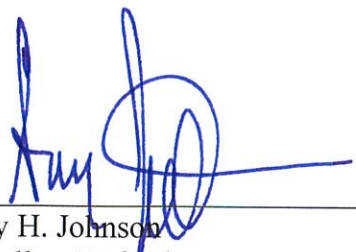
