MOTION FOR EXTENSION OF TIME TO FILE RESPONDENT'S INITIAL BRIEF
AND DESIGNATION OF MATTER TO BE INCLUDED IN THE RECORD ON APPEAL

Respondent Charleston Southern University respectfully moves under Rules 208(a)(2), 209, 240, and 263(b), SCACR for a thirty (30) day extension of time to file its Initial Brief and Designation of Matter to be Included in the Record on Appeal.
