Dear Clerk:

I represent Appellant County of York in *Midway Baptist Church of York v. County of York* (Case No. 2025-002054).

The Record on Appeal was filed on July 15, 2026. During a subsequent review of the filed Record, we discovered that pages 72 through 80 are illegible. The underlying source documents are legible, and the issue appears to have occurred inadvertently while the electronic Record was being divided into separate filing batches.

Before submitting any corrective filing, we respectfully request guidance regarding the procedure preferred by the Court. Specifically, should Appellant:

1. file the corrected replacement pages 72-80 separately, with the same page numbers;
2. file a corrected Volume 1 of the Record, containing the replacement pages 72 through 80;
3. file the corrected pages as supplemental materials in an Appendix; or
4. file a motion for leave to do any of the above.

The proposed correction would not add new material or alter the substance of the Record. It would replace only the illegible images currently at pages 72 through 80 with readable copies of the same.

We have consulted with counsel for Respondent, who consent to the Record being corrected in the manner the Court sees fit, consistent with the above.

Thank you for your guidance. After receipt, Appellant will also update the bound copy provided to the Court accordingly.
