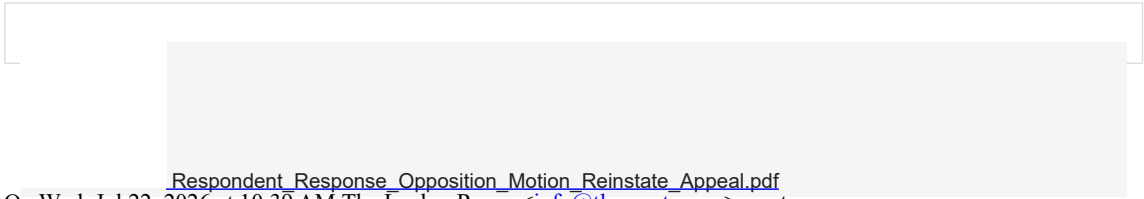

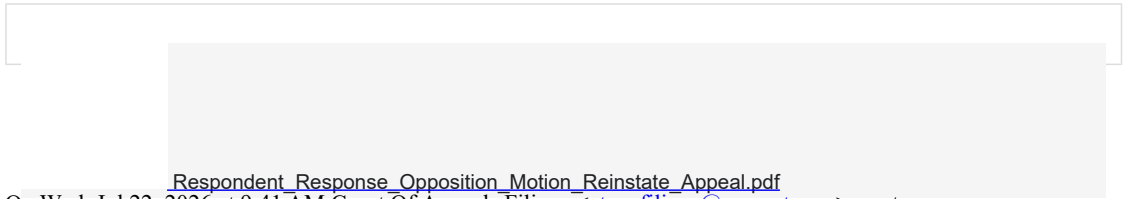

Good morning,

Thank you for taking the time to meet with me today. I appreciate the opportunity to present my concerns regarding the above-referenced case.

Attached are the documents I referenced during today's hearing for the Court's review.

During the hearing, Ms. Ford represented that she had paid the filing fee associated with her most recent appeal. Based on my communications with the Clerk's Office and my repeated efforts to verify the status of the filing fee throughout last week, I have been unable to confirm that the fee has been paid. I respectfully request that the Court verify the payment status through the Clerk's records before granting any additional extensions or relief.

If Ms. Ford contends that payment was made, I respectfully request that she be required to produce documentation showing the date the payment was made, the amount paid, and confirmation that it was received and processed by prior to June 29th. More specifically on or around May 10th, which is the date she mentioned she paid. If she cannot provide this documentation, she has lied again in court, which constitutes perjury.

Additionally, during the hearing, Ms. Ford stated that she had not been late or behind on her rental payments. My records indicate otherwise. Throughout the tenancy, there were repeated instances of late payments and requests for additional time, which contributed to the financial hardship I have experienced and continue to experience as this matter remains unresolved. Supporting documentation regarding the payment history is included with my submission.

I respectfully ask that the Court consider the documentary evidence and the procedural history of this case when ruling on the pending matters. As the prevailing party in the underlying ejectment action, I continue to incur financial hardship while enforcement of the judgment is delayed.

Note: Her asking for an extension to pay is the same as her being late with her rent and behind on her rent several times. If she fails to pay the state on time, one can infer how often she has been late or behind in paying her rent.

Thank you for your time and consideration of this matter.
