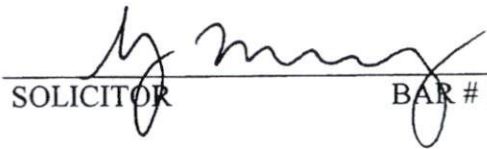
COUNT I: TRAFFICKING METHAMPHETAMINE

That DAIVION ALEXANDER BEVERLY did in Greenville County, on or about the 1st day of January 2024, knowingly sell, manufacture, deliver or bring into the State of South Carolina or did knowingly provide financial assistance or otherwise aid, abet, attempt or conspire to sell, manufacture, deliver or bring into the State or was knowingly in actual or constructive possession of 28 grams or more, but less than 100 grams of Methamphetamine (Crank). This is in violation of §44-53-0375 of the South Carolina Code of Laws (1976) as amended.

COUNT II: POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME
