EMERGENCY AFFIDAVIT OF TENANT IN SUPPORT OF
IMMEDIATE STAY PENDING APPEAL [1]

I, Natasha Foster, being first duly sworn, depose and state as follows
under penalty of perjury:

1. I am the Tenant in the above-captioned matter.
2. The lower Magistrate Court has authorized a physical eviction "set out" scheduled for tomorrow, August 5, 2026, at 11:00 AM.
3. This Court previously issued a 10-day window to file instructions regarding a new state law affidavit. However, because the lower court has refused to pause the eviction, the scheduled set out will cause immediate and irreversible harm, rendering my family homeless and destroying my statutory right to an appeal before this Court can review the case file.
4. I am ready, willing, and able to sign a Tenant Undertaking and pay ongoing rent directly into the Greenville County Clerk of Court's escrow account during the pendency of this appeal, satisfying the requirements of S.C. Code § 27-40-800.
5. I respectfully request an immediate, emergency ex parte stay to halt the scheduled 11:00 AM eviction until my underlying Motion to Stay can be formally heard and ruled upon.

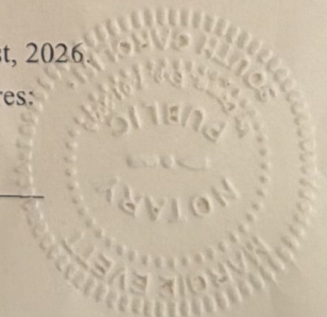
