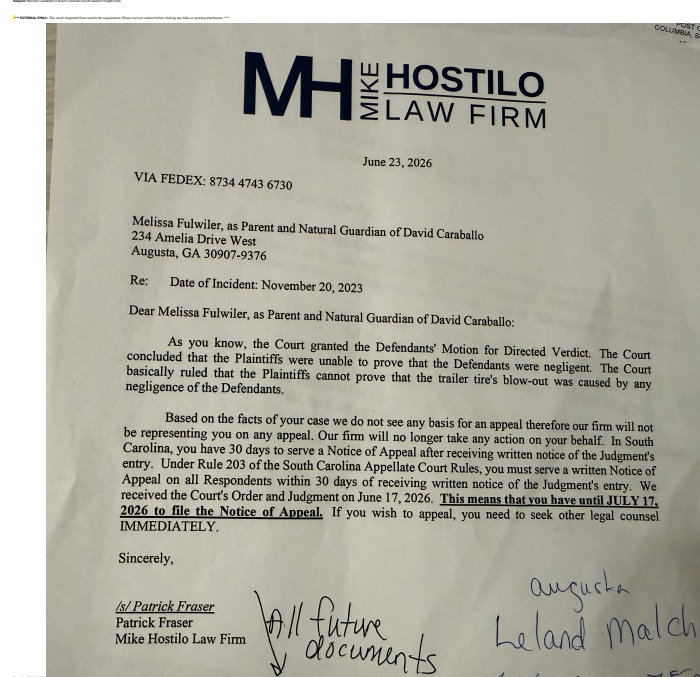
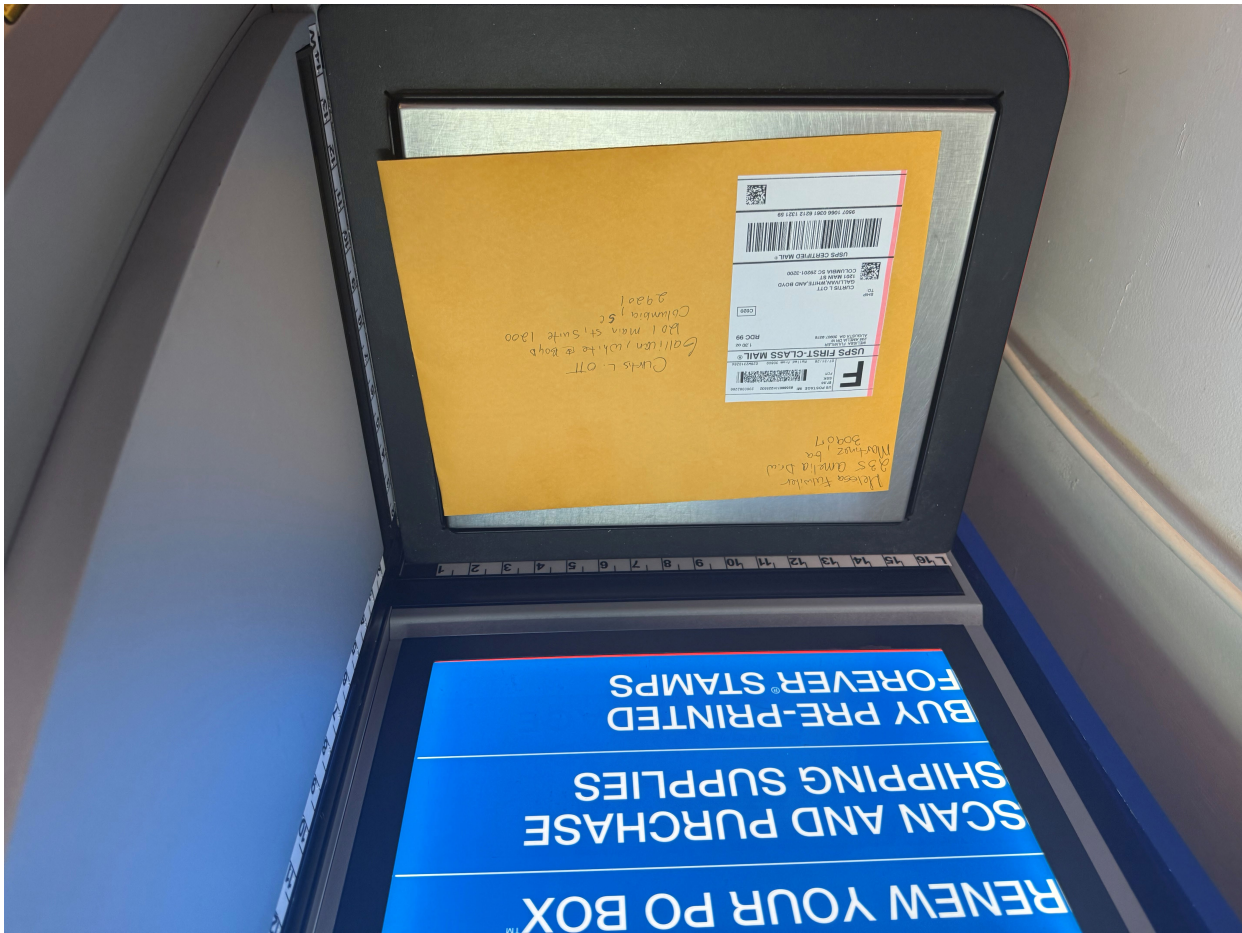

SUMMARY OF AMENDMENT TO NOTICE OF APPEAL
