APPELLANT'S MOTION FOR EXTENSION OF TIME
TO SERVE AND FILE APPELLANT'S FINAL BRIEF

TO: THE HONORABLE CHIEF JUDGE AND ASSOCIATE JUDGES OF THE SOUTH CAROLINA COURT OF APPEALS:

Appellant Cynthia Veronese, appearing pro se, respectfully moves this Court, pursuant to Rule 234, SCACR, for an extension of time of thirty (30) days in which to serve and file Appellant's final brief. In support of this motion, Appellant states as follows:

1. On July 22, 2026, this Court issued an Order denying Appellant's May 18, 2026 motion and June 16, 2026 amended motion, and directing that "Appellant has fifteen days from the date of this order to serve and file Appellant's final briefs or this appeal may be dismissed."
2. Appellant's final brief is therefore currently due on or about August 6, 2026.
3. Appellant is the sole caregiver for her ninety-six (96) year-old mother. During the time relevant to the preparation of Appellant's final brief, Appellant's mother has been hospitalized. She has remained in the hospital for approximately the past month and continues to require Appellant's constant care and attention.
4. Appellant's caregiving obligations during her mother's hospitalization have materially impaired her ability to prepare and complete her final brief within the fifteen-day period set by the Court's July 22, 2026 Order.

5. A true and correct copy of the hospital record documenting Appellant's mother's hospitalization is attached hereto as Exhibit A in support of this motion.

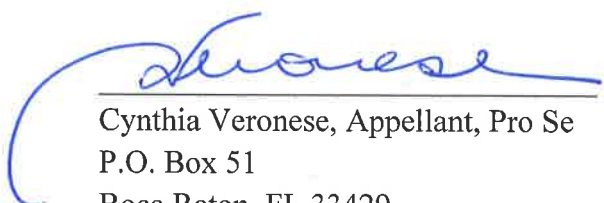
6. This motion is made in good faith and not for purposes of delay. Appellant requires the requested additional time solely to prepare a complete and adequate final brief so that this appeal may be decided on its merits.

7. Appellant respectfully submits that good cause exists for the requested extension, and that no party will be prejudiced by a brief extension of the filing deadline.

8. Prior to filing this motion, Appellant emailed counsel for Respondents, Ivon Keith McCarty, Esquire, regarding this request. Respondents do not consent on the relief requested herein.

WHEREFORE, Appellant respectfully requests that this Court grant an extension of time of thirty (30) days, through and including September 5, 2026, within which to serve and file Appellant's final brief, and grant such other and further relief as the Court deems just and proper.

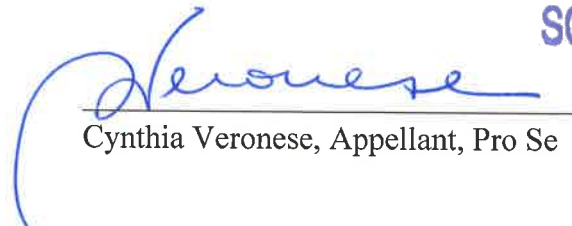
