1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.
2. Counsel filed the Initial Brief of Respondent in the case of The State v. Casey Douglas with the Supreme Court on August 3, 2026. Counsel filed the Reply to Return to Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Marc Palmer

with the Supreme Court on July 30, 2026. Counsel filed the Final Brief of Appellant, Final Reply Brief of Appellant, and Record on Appeal in the case of Dennis M. Gallipeau v. State with the Supreme Court on July 21, 2026. Counsel filed the Initial Reply Brief of Appellant in the case of Dennis M. Gallipeau v. The State with the Supreme Court on July 20, 2026. Counsel filed the Brief of Petitioner in the case of The State v. Jamar A. Huggins with the Supreme Court on July 17, 2026. Counsel filed the Petition for Rehearing in the case of Nevelle J. Eberhart v. The State with the Court of Appeals on July 16, 2026. Counsel filed the Initial Brief of Appellant in the case of The State v. Randall Gene Posey with the Court of Appeals on July 6, 2026. Counsel filed the Brief of Petitioner in the case of The State v. Timothy James Thompson with the Supreme Court on June 29, 2026. Counsel filed the Anders Brief of Appellant and Record on Appeal in the case of The State v. Jimmie McMillan with the Court of Appeals on June 15, 2026. Counsel filed the Reply to Return to Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Jharaun Washington with the Supreme Court on June 12, 2026. Counsel filed the Petition for Writ of Certiorari to the Court of Appeals in the case of The State v. Marc Anthony Palmer with the Supreme Court on June 12, 2026. Counsel will file the Anders Brief of Appellant in the case of The State v. Charlecia Lurry with the Court of Appeals today, June 5, 2026.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that his caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

4. On August 3, 2026, opposing counsel, the Attorney General's Office, graciously consented to this extension request by way of general consent granted in writing, by Deputy

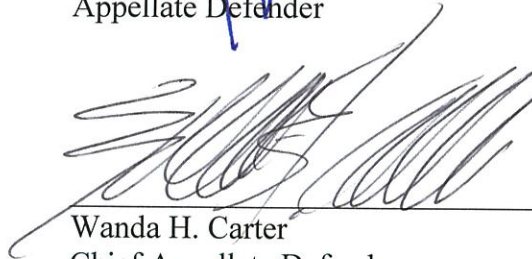
Attorney General Donald J. Zelenka for all Appellate Defense extensions through September 1, 2026.

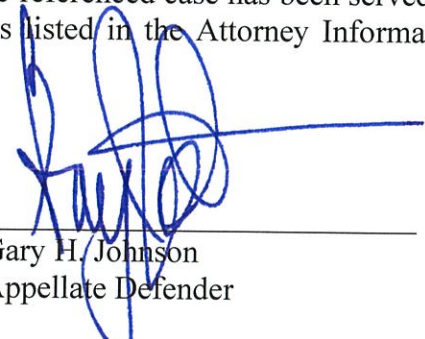
