Respondent hereby moves pursuant to Rule 263(b), SCACR, for an extension to September 14, 2026, of the time in which to serve and file Respondent’s Initial Brief and Designation of Matter to be Included in the Record on Appeal in this case. The grounds for this motion are that there is good cause to grant the requested extension, as the following shows:

1. Respondent’s deadline to file its Initial Brief and Designation of Matter is August 14, 2026.
2. Due to multiple court appearances, in and out of town, Respondent’s counsel has not had time to draft the brief in this appeal. For example, the past three weeks, Counsel has been in Court four to five days per week and is scheduled to be in Court or in depositions four days next week.
3. Respondent’s counsel believes that settlement is possible in this matter and that a settlement may soon be reached.
4. This is Respondent’s second request for an extension, the appeal has only recently been filed and a 30-day extension would not prejudice the appellant.

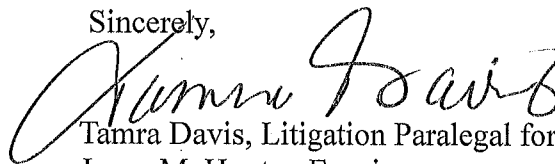
