I pray most is well. I suppose it is safe to surmise that you're not going to respond to me concerning the repeated requests I've made to the City of Rock Hill for the body cam video of the meetings that I had with Lt. Harrelson and Deputy Chief Belk of the Rock Hill Police Department respectively on June 25 and June 26, 2025 at the Rock Hill police station, and the body cam video of the black police officer who came into the RH city jail cell to unchain and unshackle me who was wearing a body camera.

As Christians, leaders of our great city, and high ranking officials and administrators in York County, I hope you both can admit that a great travesty of justice has been done against me. I pray that you are considering addressing the matter in a just, transparent, and peaceable manner in the very near future.

To reiterate, it is my belief that the City of Rock Hill Police arrested me on a bogus charge of harassment_2nd degree with the alleged victim being my ex-wife of 42 years, Jacqueline Miller, who works for the Rock Hill Police Department. The bogus harassment charge came only four months after a bitter divorce between Jacqueline Miller and I was finalized. Following that bogus charge of harassment, the City of Rock Hill bogusly incarcerated me twice more for violating the no contact order that was issued against me in conjunction with the bogus harassment charge. I was arrested via a bogus bond revocation for violating the no contact order, and again via a contempt of court charge also for violating the same no contact order. I spent a total of 36 days falsely incarcerated on these bogus charges. All three bogus charges and arrests against me...the harassment charge and the two violation of the no contact order were based on me sending Jacqueline Miller documents directly related to legitimate legal and real estate matters directly related to the divorce.

Representing myself pro se, I was found not guilty on the foundational harassment charge_2nd degree by a jury. The bogus charges have caused irreparable harm to me as a Christian minister and upstanding Rock Hill citizen by attempting to tarnish my reputation by falsely accusing me of harassment, forcing me to spend tens of thousands of dollars to defend myself against bogus allegations in an attempt to destroy me financially, falsely imprisoning me and chaining me up in jail like an animal, violating my civil rights, getting me fired from my job as a public school teacher, and repeatedly refusing to give me the requested body cam video that I am entitled to by law just to name a few things among others.

Furthermore, in this current supercharged sociopolitical and racial atmosphere of the United States of America, all of the arresting and prosecuting agents against me involved in this matter are white except my ex-wife.

As you probably know, there are many more details concerning this matter that I could reiterate concerning the undeniable and easily verifiable falsehoods set-forth by Rock Hill City employees and former employees such Chief Chris Watts, Assistant Solicitor Ben Shealy, the late Judge Peter Lenzi, and Jacqueline Miller just to name a few.

I simply desire justice, righteousness, and peace. I have no animosity nor ill feelings towards anyone, and I never will by God's grace regardless of the final outcome of all of this. It is God's doing. God has called us to be authentic examples of His son Jesus Christ. God did all of this, and all of it is necessary.

- Executive Authority: Several candidates are pushing to strip legislators of their judicial nomination powers and hand that authority directly to the governor.
- Public Bench Initiative: Proposals like Rep. Nancy Mace's "Open Bench" initiative aim to create a public, online database of all judicial ethics complaints so citizens can track patterns of misconduct.
- Recall Mechanisms: Rep. Ralph Norman has advocated for putting judicial selection in the hands of voters and establishing systems to recall "rogue" judges.

Subject: Body Cam Videos from June 25th and 26th, 2025 and Initial Arrest April 23, 2023

Hello Ms. Channel....

I hope most is well. I am contacting you to request the body cam video of the meetings that I had with Lt. Harrelson and Deputy Chief Belk of the Rock Hill Police Department respectively on June 25 and June 26, 2025 at the Rock Hill police station. They both had on body cameras at the time we met, and I requested that their cameras be operable (turned-on) at that time. I am also requesting the body cam video of my initial arrest on April 23, 2023 when I was jailed, chained, and shackled in the City of Rock Hill jail. I am specifically requesting the body cam video of the black police officer who came into the RH city jail cell to unchain and unshackle me who was wearing a body camera. While unchaining me, he assured me everything was being recorded and that the recording goes directly to a computer, and that it would take a considerable effort to deliberately erase and/or destroy the recording. I have requested this information before in accordance to Rule 5 for discovery evidence for the harassment trial (September 10, 2025) for which I was arrested on April 23, 2023, but never received it. As I plan for further legal proceedings to recoup monetary losses from my various bogus arrests and incarcerations based on restitution, compensatory, and punitive laws, these body cam videos will be valuable to my claims and assertions.

Hello Attorney Woods.....

I pray most is well. I want to make sure I'm clear on what I'm requesting, and I want to make sure I understand what you're saying you can and cannot provide me. And I want to be completely transparent and let everyone copied on this email keep abreast of what's going on, because obviously I absolutely do not trust the York County, SC judicial system.

I have been told that the City of Rock Hill will not be giving me any documents or items related to matter, and that I should make my requests concerning anything I need to prepare for the upcoming trial known to you. On yesterday, I requested the following five items from you that I did not receive in what you have given me thus far:

- 1) The transcript recording of the initial arraignment hearing for the harassment_2nd degree charge wherein I pleaded "not guilty," requested a jury trial, and over which Judge Jane Modla presided. I also had to sign a waiver at the arraignment stating I was representing myself. That was of course before I hired both Leland Greeley and Jack Swerling.
- 2) The video recording of the bond hearing (April 24, 2023) for the harassment_2nd degree charge over which Judge Anthony Triano presided and he gave me the "no contact" instructions.
- 3) The body cam footage of the black police officer who came into my cell and unchained me on the morning of April 24, 2023.
- 4) The name of the white girl on camera knocking on my apartment door at approximately 5:00 AM or so on Wednesday April 5, 2023. I have submitted this video to the court.
- 5) The name of the Rock Hill police officer on camera walking pass my apartment door at approximately 5:10 AM or so on Wednesday April 5, 2023. I have submitted this video to the court.

Initially Chief Chris Watts said he nor the Rock Hill Police Department had any knowledge or record of me calling the Rock Hill Police Department on the morning of April 5, 2023 to report the girl and officer at my door. He stated this in an email that I have submitted to the court. Only after I filed a Citizen's Complaint did Chief Watts admit that the Rock Hill Police Department did have knowledge and a dispatch record of me calling on the morning of April 5, 2023 to report the girl and RHPD officer being at my door at 5 AM, while I was 500 miles away in Kentucky at a funeral.

Besides this, the alleged victim of the bogus harassment charge (my ex-wife Jacqueline Miller) specifically mentions the white girl during her interview with the officer who documented her complaint on one of the body cam videos you sent me.

Are you telling me that although you have all the other body cam videos that you have given me, you don't have the one where the black police officer unchained me on Monday morning (April 24, 2023) while standing in a puddle of my urine, and we're talking about the matter?

And are you telling me you don't have access to or can't give me a recorded transcript of my initial arrest arraignment hearing before Judge Modla where I pleaded "not guilty", asked for a jury trial, and signed a waiver saying I understood that I was representing myself?

And finally, are you telling me you don't have access to or can't give me the recorded bond hearing over which Judge Anthony Triano presided who set my bail and gave me "no contact" orders, for which later on the late Judge Peter Lenzi while sitting on the bench of justice falsely stated that he presided over?

Clearly, all of these requested materials should easily be collected and given to me without a problem. Are you telling me I need to contact the Rock Hill Municipal Court for these items. Of course I will, if that's what I need to do, but can you please clarify. Please clarify.

Of course, it is my opinion (and I believe also God's) that this entire matter is completely outrageous, bogus, and evil.....perpetuated by a few unscrupulous humans.
