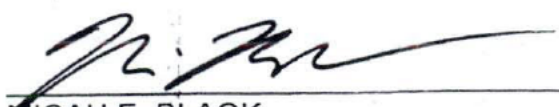

ASSAULT WITH INTENT TO COMMIT CRIMINAL SEXUAL CONDUCT

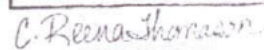

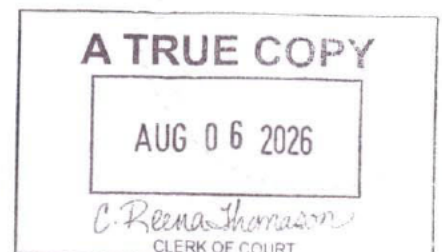
