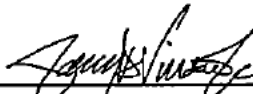

ORDER

On February 17, 2026, Appellant filed her initial appellate brief and designation of matter. On March 12, 2026, Respondent filed their initial appellate brief and designation of matter. On March 23, 2026, Appellant filed her initial reply brief. On April 27, 2026, Appellant filed the record on appeal. On May 14, 2026, Respondent filed their final appellate brief. On May 18, 2026, prior to filing Appellant's final briefs, Appellant filed a motion to "augment the record on appeal and for an extension of time in which to file Appellant's brief." We construe the motion to augment as a motion to amend the record on appeal pursuant to Rule 212(b), SCACR. On May 29, 2026, Respondent filed a return in opposition arguing an amendment at this late stage is procedurally untimely. On June 8, 2026, Appellant filed a reply. On June 16, 2026, Appellant filed an amended motion to request that an additional item be included in the amended record. After careful consideration, Appellant's May 18, 2026 motion and June 16, 2026 amended motion are denied. Appellant has fifteen days from the date of this order to serve and file Appellant's final briefs or this appeal may be dismissed.
