You have mistaken about SCDL not allowing CDs to be mailed to the correctional facilities.

Prisons are allowed to have CDs if they pertain to legal material of their case. They will keep it in property and control, and inmates have to put in a request to staff to property and control to listen to it, once contraband officer has reviewed it to make sure it legal material.
