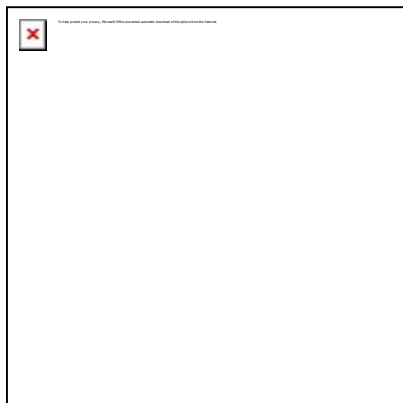
Good afternoon Madam Clerk and Judge Jordan,

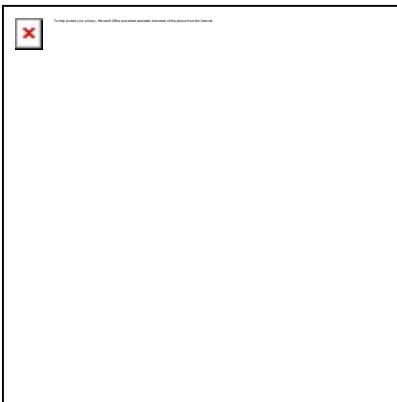
