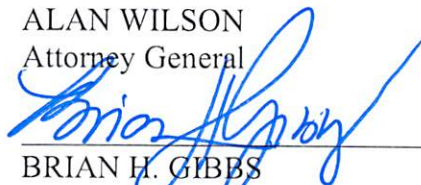
III.

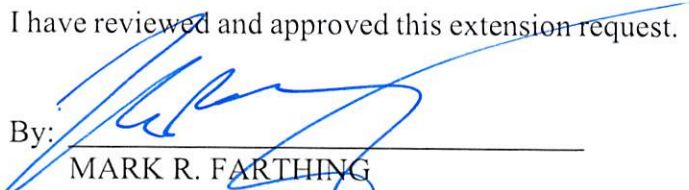
