I am submitting the enclosed Appellant's Renewed Emergency Petition for Writ of Supersedeas and for Review of Security Fixed on Remand in the above-referenced matter, App. Case No. 2026-001570.

This submission serves two purposes, and I want to flag both clearly for the Court's docketing.

First, it presents my grievance regarding the terms of security announced by the Master-in-Equity on August 20, 2026, which I respectfully submit are inconsistent with S.C. Code Ann. § 18-9-170, for the reasons set out in the enclosed petition.

Second, this submission is intended to satisfy the requirement of this Court's July 22, 2026 order that I report back to this Court, within ten (10) days of the hearing and decision on my Emergency Petition for Stay/Writ of Supersedeas, on the outcome of that hearing before the Master-in-Equity on remand. That hearing was held on August 20, 2026, and the Master-in-Equity's ruling was communicated in writing the following day, today August 21, 2026. I am submitting this update, together with the accompanying petition, within that ten-day period.

I am submitting this today, before the close of business, given the compressed ten-day compliance period described in the Master-in-Equity's own ruling (reproduced in full as Exhibit A to the enclosed petition). Please advise if any additional steps are required to properly file or docket this submission.
