Dear Court Administration:

I respectfully request that my pending transcript requests in Case No. 2022-CP-37-00108 be reassigned to another available court reporter or transcriptionist for completion. The transcripts are required for my pending appeal.

Court Administration confirmed receipt of my requests on May 23, 2026, under Request IDs 1268194841_1 and 1268194841_2, and advised that I should receive communication from a transcriptionist within five business days with an estimated cost for production.

The relevant history is as follows:

May 23, 2026: Court Administration confirmed receipt of the transcript requests. Sharon Hardoon, who was identified in connection with one of the requests, did not contact me. I received no estimate or payment instructions from her.

May 27, 2026: Mona Manley contacted me concerning another portion of the request and asked me to verify information so that she could locate the proceeding.

May 29, 2026: Ms. Manley advised that she was on extended leave but told me to let her know what I needed and indicated that she would get it to me.

June 23, 2026: I provided Ms. Manley with the additional information she had requested.

July 2, 2026: I asked Ms. Manley for an update on how to get the transcript process started and what money I needed to pay. She responded that she would pull her older files and let me know.

I also received an automated response stating that Ms. Manley was on extended leave and directing transcript matters to Court Administration. Because Ms. Manley personally responded to me notwithstanding that automated message, I understood that she was continuing to address the request.

July 14, 2026: I followed up again after receiving no further information. I received no further substantive response.

As of today, I have not received the transcripts, an estimated cost,

or payment instructions. I remain ready to make any required payment or deposit immediately upon receiving the applicable estimate and instructions.

Because the transcripts are required for my pending appeal, I respectfully request that Court Administration reassign both pending transcript requests to another available court reporter or transcriptionist so that production can proceed without further delay.

Please provide the estimate and payment instructions when the requests are reassigned.

For reference, I am attaching the conversation between myself and Ms. Manley herein.
