Good Morning, Ms. Shealy – I believe you may have intended to write *August 26, 2026*,

rather than *September, 26, 2026*, in your email below regarding the deadline for our Return.

I spoke with Petitioner's counsel (copied here) this morning, and we have agreed to postpone the deposition of the Office of the Governor that was scheduled for next week. Because the scheduled deposition was the reason for Petitioner's request for expedited relief by August 31, 2026, that request is now moot.

Pursuant to Rule 245(c), I understand that we have 20 days from the date of service in which to file our Return, which would make the Return due on or before September 14, 2026.
