Tracey D. Turner, Appellant, pro se, respectfully submits this written status update pursuant to this Court's April 29, 2026 Order holding this appeal in abeyance pending the bankruptcy proceedings and the Clerk's June 25, 2026 letter directing Appellant to provide written status updates regarding the bankruptcy proceedings every sixty (60) days.

Turner Development, LLC's Chapter 11 bankruptcy case remains pending in the United States Bankruptcy Court for the District of Columbia, Case No. 26-00077-ELG. The debtor has continued to file its required monthly operating reports and to comply with applicable Chapter 11 reporting requirements.

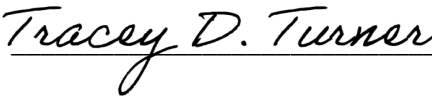
Since Appellant's prior status update filed June 23, 2026, the bankruptcy case has continued to proceed. The debtor remains engaged in administration of its Chapter 11 estate, including matters related to the marketing and proposed sale of its real property located at 1001 Old Aiken Road, North Augusta, South Carolina 29841.

The debtor's application to employ Coldwell Banker Commercial Realty and Patrick Register as real estate brokers for the estate remains pending. The Bankruptcy Court has scheduled a hearing on that application for September 9, 2026. No final order on the application has been entered as of the date of this status update.

The Chapter 11 case has not been dismissed, converted, or closed. Appellant will continue to provide written status updates as directed and respectfully requests that this appeal remain in abeyance pending further proceedings in the bankruptcy case.
