NOW COMES Plaintiff, by and through Counsel, pursuant to Rule 55(b)(2) of the South Carolina Rules of Civil Procedure and moves this Court for an Entry of Default and Default Judgment against Defendant, Joshua Shumpert, in the above-captioned case. In support of its Motion, Plaintiff submits the following to the court:

1. On or about March 25, 2025, the Plaintiff filed this action against the Defendant for a sum certain or a sum which can by computation be made certain.
2. Plaintiff's Summons and Complaint against the Defendant was served on May 5, 2025, as evidenced by the filed Affidavit of Service.
3. More than 30 days have elapsed since service of the Summons and Complaint and the Defendant failed to Answer or otherwise plead or request an Extension of Time in which to answer.
4. The Plaintiff's claims asserted herein are for a liquidated sum set forth in the previously filed Complaint or Affidavit of Damages.
