**RETURN TO APPELLANT’S MOTION TO CERTIFY**

---

Respondent Matthew T. Siedhoff, M.D. respectfully opposes Appellant Anonymous Surgeon’s Motion to Certify pursuant to Rule 204(b) of the South Carolina Appellate Court Rules. In his motion, counsel for Appellant asks the South Carolina Supreme Court to review this case and not only reverse the lower court’s decision but reverse the firmly-established precedent related to the exceptions to South Carolina’s Survival Statute. However, the issues in this case do not merit deviation from the standard appellate process.


SCACR Rule 204(b) states that “[c]ertification is normally appropriate where the case involves an issue of significant public interest or a legal principle of major importance.” The issue which Appellant asks the Court to review was established by this Court 65 years ago when the common law exceptions to the Survival Statute were first

established in South Carolina case law in *Carver v. Morrow*, 213 S.C. 199, 48 S.E.2d 814 (1948). These exceptions have been repeatedly reaffirmed by various South Carolina courts since then. See *Brewer v. Graydon*, 233 S.C. 124, 103 S.E.2d 767 (1958); *Belcher v. S.C. Bd. of Corr.*, 460 F.Supp. 805 (1978); *Schneider v. Allstate Ins. Co.*, 487 F.Supp. 239, 245 (D.S.C. 1980). The issue in this case is not a matter of “significant public interest.” To the contrary, changing 65 years of settled law would create unnecessary confusion.

WHEREFORE, Respondent respectfully opposes Appellant’s Motion to Certify this case to the South Carolina Supreme Court.




