MOTION TO DISMISS AN APPEAL

On September 4, 2025, in response to Appellant's motion filed in Case No. 2021-CP-28-0795, Judge Daniel Coble filed an Order, as follows:

"This is a probate appeal which ended with the probate court being affirmed. My decision was appealed to the Court of Appeals where the lower court was upheld, order attached. **There is no judgment in this case and no paperwork will be added to this ended appeal.**" (emphasis added)

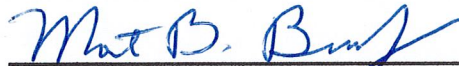
The Court of Appeals Order to which Judge Coble refers is Hennager v. Deardon, Op. No. 2025-UP-196 (S.C. Ct. App. filed June 11, 2025). Thereafter, Appellant's writs of certiorari to the South Carolina Supreme Court and the Supreme Court of the United States were denied.

In spite of the above, Appellant filed motions again in the circuit court resulting in another Order by Judge Coble, filed July 14, 2026, which reiterates his prior Order as follows:

"This matter is closed based on the Court of Appeals opinion filed June 11, 2025, and **this court will not accept any more filings.**" (emphasis added)

It is the above Order, which Appellant now appeals. It is clear that this frivolous appeal should be dismissed, with sanctions under Rule 269, SCACR.
