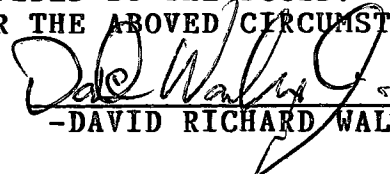

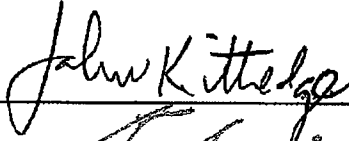

ORDER

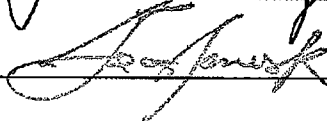
The South Carolina Commission on Indigent Defense, Division of Appellate Defense, has moved for the appointment of outside counsel in this matter. Because Petitioner is proceeding pro se in this matter and the Division of Appellate Defense has not been appointed as counsel for Petitioner in this matter, we deny the motion.

Petitioner has filed a motion for a no-cost transcript of a post-conviction relief hearing held on December 14, 2021, before the Honorable R.L. McIntosh. The motion is granted. We hereby associate the Commission on Indigent Defense, Division of Appellate Defense, for the limited purpose of obtaining and paying for any necessary transcript. Petitioner shall communicate with the Division of Appellate Defense for the purpose of coordinating these services.

The time for serving and filing the petition for a writ of certiorari and appendix is held in abeyance pending notice from the Division of Appellate Defense to this Court, with a copy sent to Petitioner, that the transcript of the hearing has been provided to Petitioner. Petitioner shall have thirty days from the date of that notice to serve and file the petition for a writ of certiorari and appendix in this matter.
