That on or about 02/15/2024 while at 701 Assembly Street (UofSC Carolina Coliseum) in the Olympia Magisterial District of Richland County, it is believed that the defendant did commit the crime of Indecent Exposure because he did willfully, maliciously, and indecently expose his person in a public place in view of another person. The victim reported to police that a male was observed in the hallway with his genitalia exposed and that the male was masturbating while looking at her. Indecent Exposure

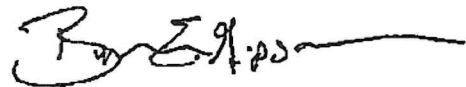
