PETITION FOR A WRIT OF CERTIORARI

Petitioner Jason Fetzer respectfully petitions the Supreme Court of South Carolina for a writ of certiorari to review the decision of the South Carolina Court of Appeals in this matter.

I. DECISION SOUGHT TO BE REVIEWED

Petitioner seeks review of the South Carolina Court of Appeals' decision denying/dismissing his appeal and the subsequent denial of his Petition for Rehearing.

Petitioner first received actual notice of the Court of Appeals' disposition by regular mail on **June 26, 2026**.

II. QUESTIONS PRESENTED

1. Whether the Court of Appeals erred in dismissing or denying Petitioner's appeal where Petitioner maintains that he was not properly notified of the proceedings or disposition.
2. Whether Petitioner's constitutional right to meaningful appellate review and due process was violated by the circumstances surrounding the filing, processing, notice, and disposition of his appeal.
3. Whether the Court of Appeals should have considered the circumstances affecting

Petitioner's ability to timely receive notice and meaningfully pursue appellate review.

III. REASONS CERTIORARI SHOULD BE GRANTED

Petitioner respectfully requests review because this matter involves substantial questions concerning due process, meaningful access to the courts, and Petitioner's ability to obtain appellate review of the underlying proceedings.

Petitioner contends that the procedural history of this matter raises issues that warrant review by the Supreme Court of South Carolina.

Petitioner further requests that the Court examine the record concerning the filing and processing of his appeal, the notice provided to him, and the circumstances surrounding the disposition of the appeal.

IV. RELIEF REQUESTED

Petitioner respectfully requests that this Court:

1. Grant the Petition for a Writ of Certiorari;
2. Obtain and review the record of the proceedings below;
3. Review the decision of the South Carolina Court of Appeals;
4. Determine whether Petitioner's constitutional and appellate rights were violated; and
5. Grant such other relief as this Court determines to be just and proper.
