OBJECTION TO RESPONDENTS' MOTION FOR EXTENSION OF TIME

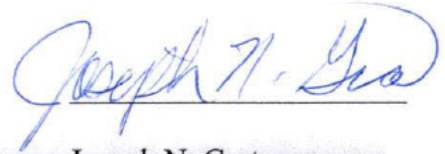

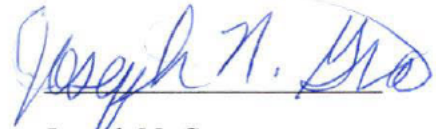
