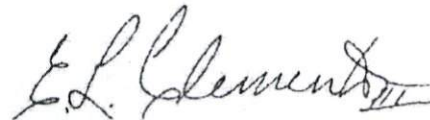
At a , convened on March 26, 2026, the Grand Jurors of Marion County present upon their oath:
