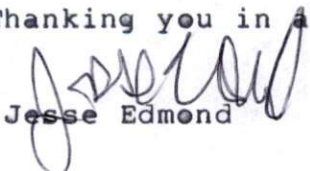

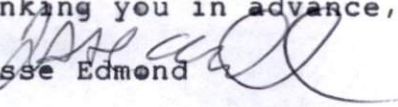
Dear Jessica Antonucci:
