Good afternoon. I am confused by the court's latest correspondence. As noted in the cover email by which the notice of appeal was submitted, I already had the transcript at that time.

Because the deadline to submit the initial brief was 30 days from when the notice on appeal was served and filed, I moved for an extension of its deadline because the court had not yet acted on the then-pending motion to amend the notice of appeal. The court sent me a letter saying that the deadline was being held in abeyance and that no action would be taken on the extension motion. Accordingly, it had been my impression that the deadline to submit the initial brief is August 3, 2026, which is the first workday after the passage of 30 days from the date of the order that denied the motion to amend the notice of appeal.

In any event, please let me know the court's position on when the deadline is to serve and file the appellant's initial brief.
