NOTICE OF APPEAL

Appellant Camelia Socite appeals from: (1) the August 7, 2026 Statement of Judgment granting Mandarich Law Group, LLP's Rule 12(b)(2), SCRCF motion and dismissing Mandarich from this action for lack of personal jurisdiction; and (2) the August 28, 2026 Statement of Judgment denying Appellant's timely August 10, 2026 motion to reconsider, revise, and clarify, insofar as that ruling leaves the Mandarich dismissal in place.

Appellant received written notice of entry of the August 28, 2026 order on August 28, 2026.

This appeal is limited to the dismissal of Mandarich and the denial of post-order relief as to Mandarich. It does not seek review of rulings concerning PACS Group, Inc. or Edgefield Community Healthcare, LLC d/b/a Edgefield Post Acute, including the August 7 discovery ruling directed to those defendants. No related appeal is known.

The August 7 Statement of Judgment also directs Mandarich's counsel to prepare a formal order. This Notice is served and filed now to preserve Appellant's appellate rights. Appellant reserves the right to serve and file an amended or supplemental notice after receipt of any later formal order concerning the Mandarich dismissal.
