NOTICE OF APPEAL

Chemar Treyvon Black had a jury trial and was found guilty on August 26, 2026, for the charges of Trafficking Fentanyl 4-14 grams, 2nd offense, Trafficking Methamphetamine 28-100 grams, 2nd offense, Possession with Intent to Distribute Cocaine Base, 2nd offense, and 2 counts of Possession of a Firearm by a Person Previously Convicted of Possession with Intent to Distribute a Controlled Substance. He was sentenced to Life without Parole (LWOP) for 3 drug charges and 5 years each for the weapon charges. All sentences are concurrent.

Mr. Black appeals the denial of the pre-trial motion to quash the search warrant and suppress the evidence in this case. He appeals the verdict and sentences for the above referenced charges. He also appeals the denial of the motions for directed verdict and the motion for new trial.
