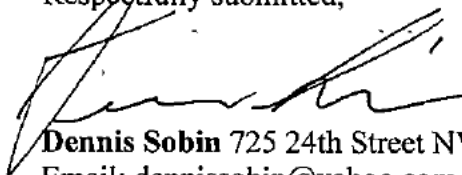
The Order appealed from states, in relevant part:

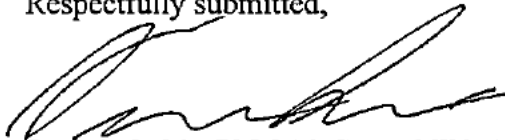

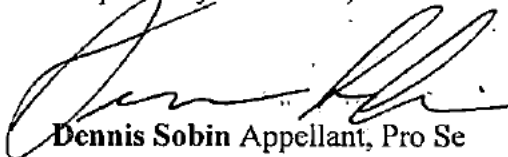
