MOTION FOR AN EXTENSION OF TIME

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

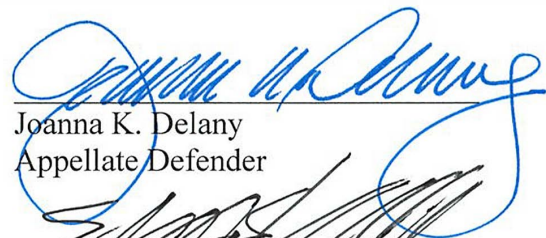

Counsel filed the Petition for Writ of Certiorari to the Court of Appeals and the Appendix in the case of The State v. Marcus Alexander Wigfall with this Court on August 14, 2026. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Michael Todd Roberts, Jr. with the Court of Appeals on August 12, 2026. Counsel filed the Initial Brief of Appellant and Designation of Matter in the case of The State v. Dontrell Henry Rufus with the Court of Appeals on July 29, 2026.

4. Counsel makes this request in good faith and not for purpose of delay.

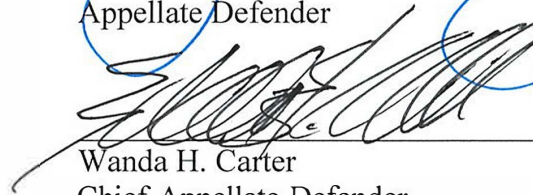
