**FIRST CONSENT MOTION FOR EXTENSION OF TIME TO FILE AND SERVE
THEIR INITIAL BRIEF AND DESIGNATION OF MATTER FOR INCLUSION IN THE
RECORD ON APPEAL OF APPELLANTS KIMBERLY THOMASON, DEVON
PURIEFOY, DESA BALLARD, MAYRA MICHALSKI, LUIS MICHALSKI, AND
MARGARET MINIARD**

AND NOW COMES Appellants Kimberly Thomason, Devon Puriefoy, Desa Ballard, Mayra Michalski, Luis Michalski, and Margaret Miniard (collectively "Appellants"),¹ by and through their undersigned counsel, pursuant to Rule 263(b), SCACR, and move for an extension of thirty (30) days additional time to file and serve their Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal:

1. On August 11, 2026, Appellants filed their Notice of Appeal in this matter.
2. There are no transcripts to be ordered for this appeal.
3. As a result, Appellants' Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal are due on or before September 10, 2026. *See* S.C.R.A.P., Rule 208(a)(1) ("Within thirty (30) days after receiving the transcript or, if no transcript is ordered, within thirty (30) days after serving the notice of appeal, appellant shall serve one copy of his brief on all parties to the appeal, and file with the clerk of the appellate court one copy of the brief with proof of service.").
4. Due to the complexity and volume of issues in this appeal and the schedule of Appellants' counsel, Appellants respectfully request an extension of 30 days from September 10, 2026 to file and serve their Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal.
5. Specifically, Appellants respectfully request that the Court extend this deadline by 30 days, until Monday, October 12, 2026 (because October 10, 2026, falls on a Saturday).
6. Appellants believe that this relief is consistent with the interests of justice and will not work any undue prejudice upon any party.
7. Counsel for Respondents have graciously consented to the relief requested herein.

¹ The term "Appellants" in this filing does not include Appellant Stacey Grist, who is represented by separate counsel.

WHEREFORE, for the foregoing reasons, Appellants Kimberly Thomason, Devon Puriefoy, Desa Ballard, Mayra Michalski, Luis Michalski, and Margaret Miniard move this Honorable Court to grant them an extension of 30 days to file and serve their Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal related thereto. With the requested extension of time, the new deadline for filing and serving the Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal will be October 12, 2026. Additionally, Appellants respectfully request that the Court hold their present deadline for the service and filing of their Initial Brief of Appellants and Designation of Matter for Inclusion in the Record on Appeal in abeyance until it acts upon this Motion.

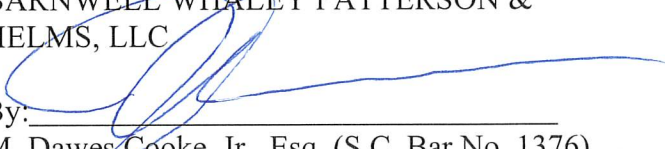
