MOTION FOR EXTENSION FOR RETURN
TO MOTION FOR SANCTIONS

Respondent, Lisa Lee Molstad, respectfully moves for a ten-day extension of the deadline for serving and filing a return to the motion for sanctions filed by Appellant, Hugh Parks Price, and in support of this extension motion, Respondent states as follows:

1. The motion for sanctions was served and filed September 3, 2026, therefore the due date for a return is September 14, 2026.
2. The motion for sanctions is based on allegations Appellant has made against Respondent's prior attorney, Christian G. Spradley, for whom Respondent's current counsel was substituted by order of the Court of Appeals dated July 8, 2026.

3. Respondent's current counsel is engaged in a lengthy trial in the Lexington County Court of Common Pleas, which began Tuesday, September 8, 2026, and is scheduled to continue through Friday, September 11, 2026, with the possibility that it will not be concluded until Monday, September 14, 2026.

4. Due to counsel's trial schedule, it will be impossible for him to prepare a return to the motion for sanctions by the current due date of September 14, 2026.

5. Due to counsel's trial schedule, Respondent seeks an additional ten days in which to prepare, serve, and file a return to the motion for sanctions.

6. This motion is not made for purpose of delay but due to the genuine time constraints placed on Respondent's counsel by his current trial schedule.

7. No prejudice will result to Appellant if the requested ten-day extension is granted.

WHEREFORE, Respondent respectfully moves for a ten-day extension of the current deadline for a return to the motion for sanctions, to September 24, 2026.
