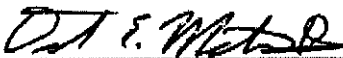

The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

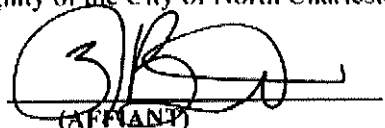
That on April 15, 2023 at approximately 09:06 PM, while at 3821 St Johns Ave, which is located in the City of North Charleston, County of Charleston, State of South Carolina, the defendant, one **Jalen Lee Brothers**, did knowingly and unlawfully commit the offense of **POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME** in violation of 16-23-490 of the South Carolina Code of Laws 1976 as amended. In that the defendant did commit the offense of attempted murder while armed with a firearm.

Facts to establish the aforesaid are that on April 15, 2023, officers with the North Charleston Police Department were dispatched to [REDACTED] in reference to a shooting. Upon arrival officers located the victim in the parking lot suffering from multiple gunshot wounds. The victim advised responding units that he was shot by a male wearing shorts, flip flops, a backpack and a jacket. A witness in the area advised that a black male wearing a grey jacket was in an altercation before they heard the shots, and he fled on foot down [REDACTED] towards the bar which is located [REDACTED]. K9 units were on scene and immediately started to track. While tracking, K9 units located a grey in color jacket that appeared to be freshly discarded along the flight path of the suspect. Units in the area also observed a male in the area fitting the description at which time he fled on foot. He discarded a book bag which was recovered by North Charleston Police Crime Scene. A firearm was recovered inside the bag along with paperwork with the above defendant's name. Officers were able to look at the above-named defendant's South Carolina DMV photo and confirmed that was the subject that fled from them and discarded the book-bag. The firearm was test fired and entered into IBIS NIBIN and preliminary matched the shell casings recovered from the incident location. Detectives reviewed City owned asset cameras in the area where the subject was last seen and the above-named defendant is observed on those cameras at approximately 1:21 P.M. on the day of the shooting wearing items matching the descriptions of the shooter and items recovered in the flight path of the defendant to include the jacket, book bag, and one of the slides (shoes) recovered.

All based on the investigation of Det. J. Butler and statements provided by the victim who is witness to prove the same. All this done against the law, peace and dignity of the City of North Charleston and the State of South Carolina.

A firearm was recovered inside the bag along with paperwork with the above defendant's name. Officers were able to look at the above-named defendant's South Carolina DMV photo and confirmed that was the subject that fled from them and discarded the book-bag. The firearm was test fired and entered into IBIS NIBIN and preliminary matched the shell casings recovered from the incident location. Detectives reviewed City owned asset cameras in the area where the subject was last seen and the above-named defendant is observed on those cameras at approximately 1:21 P.M. on the day of the shooting wearing items matching the descriptions of the shooter and items recovered in the flight path of the defendant to include the jacket, book bag, and one of the slides (shoes) recovered.

All based on the investigation of Det. J. Butler and statements provided by the victim who is witness to prove the same. All this done against the law, peace and dignity of the City of North Charleston and the State of South Carolina.
