This is an affidavit stating I, Craig Ninja Antonio Brewton, being duly sworn upon my oath, depose & say that I know the contents thereof in this affidavit is true, that it includes every ground known to me for vacating the conviction & sentence attacked in this application. The matters & allegations therein set forth are true, I'm competent to stand trial.

- 1) Dep. Matthew C Smith illegally searched & seized Mr Brewton looking for Marcus David Ross Barlow with a arrest warrant for Mr Barlow But seized Mr Brewton, the suspects car, & home unlawfully with Mr Brewton not on the arrest warrant. An arrest wasn't being made when he ran from the police, to challenge the conviction.
- 2) Dep Christopher violated my due process stealing old collectable \$100 & \$50 bills from a closed safe violating section code 23-1-240 not wearing BWC of the destruction of the safe & home of Mr Barlow with Dep Clark not wearing BWC Also.
- 3) Dep Clark, Dep Rojas, & Dep Smith fabricated police reports to get a search warrant on 9/19/22 after injuring Mr Brewton to then get a Search Warrant.
- 4) Judge Mark Hayes II conspired against Mr Brewton in a letter telling Ms Jennifer Wells a paid lawyer & Christopher Grubbs not to represent Mr Brewton violating the 6th amendment right to counsel, right to defense, ineffective counsel, & right to present witnesses to the jury as a defense.
- 5) The state of SC doesn't have evidence to say that the legal money proceeds are traceable to drug activity being old collectable funds in a closed safe without taking pictures of the collectable money serial numbers.
- 6) Prosecutor Tyler Bryant Brown tampered with my witness extracting information from Annetta Brewton intimidating her for trial.
- 7) Judge Keith R Kelly allowed prosecutor Tyler Bryant Browns actions hearing the statement at trial & allowed destroyed evidence & Constitutional violations with injuries.
- 8) On 9/19/22 I was injured during an arrest unlawful violating my rights with injuries of a dislocated right shoulder with surgery & a spinous process fracture in C7 of my neck vertebrae.
- 9) The evidence stolen & destroyed is exculpatory evidence for my case that was legally obtained from unemployment benefits, taxes from 2020-2022, stimulus taxes with stimulus refunds, & odd jobs worked in lawn care maintenance, box truck jobs & cutting hair.

This is a third motion to suppress all evidence found on 9/19/22 during an illegal search & seizure with excessive force. Deputy Matthew Smith unlawfully blocked in a car driven by the Plaintiff (PL), seizing the (PL) & the car at that moment. The sheriff officers had an arrest warrant for Marcus David Ross Barlow. Mr. Barlow was never on the scene making the search invalid, unlawful, & making Christopher Rojas police report an act of perjury lying about Mr Barlow being on the scene fleeing. The officers also confiscated legal money from a combination coded bag (safe) & safe with two handguns not producing all of the funds into evidence leaving out \$7,000 (\$17,405) & destroying key exculpatory evidence (cellphone) without body camera being on for footage & without a present supervisor to supervise the illegal acts of misconduct. The state has conspired to cover up the victim's injuries along with excessive force (E(F)) by placing the victim in jail in a cell without proper medical. The victim sustained serious physical injuries at 11:06 a.m. 9/14/22 & the search warrant was issued without probable cause after the injuries to cover up the acts at 11:53 a.m. on 9/19/22. I have never called 141 Tecanna Drive my home, I have never told the police that the residence is mine to put on my information as my place of residence, I was not in physical possession of any drugs, the residence (Tecanna) is Mr Barlow's home, I was not seen placing anything in the house, & I was not there for any drug transaction. The State destroyed potentially exculpatory evidence in bad faith violating my due process rights, & a Brady violation by Christopher Rojas destroying cell phone.

Evidence "PTM"

The state maintained exclusive control over the evidence in which it is useful evidence of purchase of gun receipts, stimulus refund receipts, tax refund receipts, & transactions of proof of revenue from babysitting, cutting grass, & cutting trees. The smell of hemp/cannabis is not probable cause with a closed door & without exigent circumstances. Judge Mark Hayes II wrote a letter to both my private attorney & public defender to inform lawyers not to represent me showing bias & prejudice causing a breakdown in client (criminal def) & defense counsel. When the government deliberately interferes with the confidential relationship between a criminal def & defense counsel violates 6th amendment right to counsel prejudices the criminal def. The judges acts caused the criminal def to fire both lawyers with the breakdown in the relationship leaving the def. Prose. Any statement derived from the ^{illegal} unlawful search & seizure should be suppressed (State v Luna) with a Franks Hearing (Franks v Delaware) because of fruits of a poisonous tree. Due to outrageous government misconduct with Sheriff Chuck Wright being sentenced, this is apples from the tree of his misconduct. The patient is a^[DK 1T] 37 y.o. male^[DK 2T] with^[DK 1T] relatively benign medical history for chronic problems who presents with neck pain^[DK 1M]. Patient states he has been arrested numerous times during which there were physical altercations and he sustained some injuries to his neck and extremity. These arrest occurred earlier in the 2020s. He reports that he has been incarcerated since 2024 when he was last arrested. He used to use a neck brace for comfort at night, but it was taken away from him in jail and he is here specifically requesting a replacement neck brace due to chronic left-sided neck pain. Additionally he notes that one of his left lower molars has been aching for 6 months. He denies facial swelling, drainage, fevers.^[DK 3M]

General: Awake with normal alertness. Attentive to my conversation and examination. Non-distressed.^[DK 1T]

Head:^{[DK 3M];[DK 1T]} Reasonably good dentition. The left maxillary third molar shows evidence of dental caries and is somewhat tender with percussion, likely chronically fractured. There is no adjacent fluid collection or expressible drainage. The floor the mouth is soft. Posterior oropharynx is clear with a midline uvula. There is no trismus. He has a normal contour of the face.^[DK 3M]

Back:^[DK 1T] Patient has no skull base or midline spinal tenderness. He is mildly tender in the left paracervical musculature with no soft tissue abnormality there. There is a negative Spurling test bilaterally. Confrontation strength testing of shoulder elbow and wrist is normal in flexion extension.^[DK 3M]

ASSESSMENT AND PLAN

The patient is a^[DK 1T] 37 y.o. male^[DK 2T] who presents with^[DK 1T] several years of left-sided neck pain, requesting a neck brace to have while he is in jail as it was recently taken away from him. He also Dors is 6 months of a left-sided toothache without fevers or facial swelling. His vital signs are elevated blood pressure and a mild tachycardia which is downtrending on my examination. He appears nontoxic on examination.

Overall presentation is consistent with a paracervical strain. I recommended against cervical immobilization as I believe a collar would be compressing the area where he is having discomfort. I did say he could try a soft collar,
