The above named defendant, respectfully moves the Honorable Court for an order of Clarification or amendment of sentence. He is sentenced as and/or for:

Trafficking Cocaine 10-28 grams First offense. The offense was then changed to 2nd offense trafficking 5-30 which changes the CDR code to 0387.

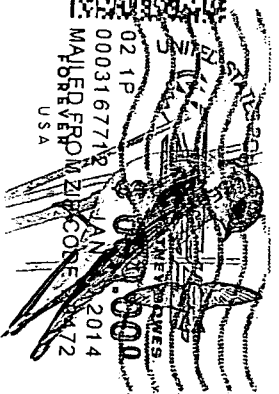
