1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.



On Thursday, December 19, 2013 counsel filed the initial brief of appellant and designation of matter in the case of State v. Akeem Smith in the Court of Appeals On Thursday, December 12, 2013, counsel had an oral argument in the Court of Appeals in the case of State v. Kevin Bennett. On Friday, December 6, 2013 counsel filed the petition for writ of certiorari and accompanying appendix in the case of State v. 
