APPELLANT’S REPLY TO RESPONDENT’S “RETURN IN OPPOSITION TO
APPELLANT’S MOTION TO REINSTATE

On January 5, 2014, Appellants received a “RETURN IN OPPOSITION TO APPELLANT’S
MOTION TO REINSTATE” from the Respondent dated December 30, 2013.

FIRST REPLY:

Respondent contends that the Appellant’s motion to reinstate should be denied because
Appellants appeal was dismissed on November 25, 2013 for failure to file Intial Brief and
Designation of matters. Respondent also further referenced Rule 260(a) SCACR, which states an
Appellant have 15 days to file a “motion to reinstate” (the day of filing being excluded) after

dismissal. However, Appellants actually received the “order of dismissal” (dated December 18, 2013) on December 20, 2013. Upon receiving the “order of dismissal” the appellants researched the appellate court rules, prepared and mailed their “motion to reinstate” the same day, which was dated December 20, 2013 (**Order of dismissal attached**).

Due to rushing, the appellants’ “motion to reinstate” states December 14, 2013, but that date is incorrect. The actually date received is December 20, 2013 and “order of dismissal” is attached to clear up any discrepancy.

The Appellants have been on top of this case from day one and have been filing numerous timely motions with the lower court, S.C Court of Appeals and even the S.C. Supreme Court. In any event, allegations of the “unauthorized practice of law” in the lower court, attorney fraud and the “Master” willful failure to answer timely post-trials motions (attached 1st and last page- petition for writ of supersedeas” and motion from relief from judgment) should be of grave concern for this court.




