extension of time.





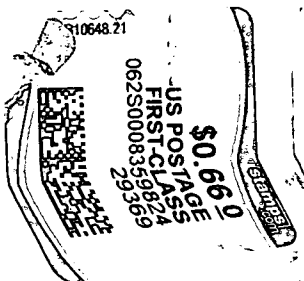
