Dear Deputy Clerk Allen:

I am in receipt of your letter dated December 20, 2013 which appears that the date has been altered using some form of "white out". I received this letter on Saturday, January 4, 2014. Thank you for acknowledging the receipt of all three orders that challenged the notice of appeal. The copy of the transcript was mailed through the U.S. Postal service PRIORITY MAIL [see postal receipt attached with first two pg cover sheets] on December 02, 2013 alone with proof of service. The transcript sent to the SC Court of Appeals was never returned to the above sender. Now, if for some reason the binder which contained the transcript was never logged-in or received by Clerk Diane, please advise and I will make another copy and forward ASAP.

I followed up with two phone calls to Clerk Diane. The first phone call was on December 6, 2013 and left a message for return call which I never received. The next phone call to Clerk Diane was on December 11, 2013 and left a message for return phone call to verify receipt of all documents sent thus far which included copy of the transcript in binder sent on December 2, 2013. Again, I never received a return phone call. I also sent an e-fax to Clerk Diane on December 18, 2013 using fax number 8037341839 to again, confirm receipt of the transcript. Again, no reply to my fax request sent on 18th December 2013.

I am aware based on my initial conversation, the first week in November, 2013, with Clerk Diane, as she informed me that she has over one hundred cases to supervise and it is quite difficult to respond and keep up with all documents. I cannot say what happened to the case transcript which I mail 2nd December 2013. The case transcript arrived at the South Carolina Court of Appeals on December 3, 2013. Maybe through negligence it was sent to the wrong clerk or discarded in some way. If for some reason the transcript cannot be located, please advise me in writing the next five days. I will pay for the cost of getting another copy of the transcript, plus pay for the mailing cost, again to this court.


